#### PRIMARY COMMERCIAL RATING FACTOR CORRECTIONS

Two of the primary rating factors (for light trucks) in the rate changes effective April 1, 2008 are corrected in the TAIPA Rules and Rating Manual (which is located on the TAIPA website) as follows:

**Page C-13:** 

### Non-Fleet Primary Classification - Primary Rating Factors and Statistical Codes

Size Class: Light Trucks (Other Than Farm)

Radius: Intermediate 51 to 200 miles

Business Use Class Retail (022): Factor of 1.80 vs. 1.56 Business Use Class Comm'l (032): Factor of 1.56 vs. 1.85
