SUBJECT: Insurer Responsibilities and Compensation Distribution;

UNCERTIFIED, SUSPENDED or REVOKED Producers

DATE: September 10, 1996

This bulletin is intended to assist companies in resolving discrepancies regarding action taken against producers through TAIPA's Producer Certification Program. Currently TAIPA can take three types of action against a producer's certification status: UNCERTIFIED, SUSPENDED, and REVOKED.

A producer may become UNCERTIFIED due to failure to follow proper certification procedures, or failure to provide TAIPA a copy of the Texas Department of Insurance license renewal. TAIPA staff may also take action to temporarily place into an UNCERTIFIED status any producer who fails to follow proper procedures; the "uncertified" status is lifted once the producer complies with TAIPA requirements.

If an assignment notification card is marked "UNCERTIFIED" the producer is uncertified FOR THAT ASSIGNMENT; however, the producer may become certified, if he has met TAIPA certification requirements, for future assignments which are NOT marked "UNCERTIFIED." Records are flagged "uncertified" on an assignment-per-assignment basis.

An UNCERTIFIED producer may NOT utilize TAIPA's electronic binding program, and may NOT earn compensation on applications submitted while UNCERTIFIED. The assigned company must request that the named insured designate an alternate, certified producer of record; in the event that no alternate producer is designated, the UNCERTIFIED producer may NOT earn premium compensation upon renewal of the policy. Companies should keep in mind that a producer who is flagged "uncertified" may shortly thereafter meet certification requirements; in this case, the insured may contact the carrier advising the producer of record is now certified.

A producer who regularly fails to follow proper procedures may be reported to TAIPA's Producer Review Panel; this Panel may recommend that the TAIPA Governing Committee SUSPEND or REVOKE the producer's certification status.

SUSPENDED producers may NOT utilize TAIPA's electronic binding program, and may NOT earn premium compensation on applications submitted while SUSPENDED; however, SUSPENDED producers MAY service EXISTING and RENEWAL policies while SUSPENDED.

Producers are SUSPENDED for a specific time period (NOT an assignment-per-assignment basis as with an "UNCERTIFIED" status); the Producer Certification Rules of Operation mandate that SUSPENDED producers must attend a training course at TAIPA before the suspension will be lifted and the certification status reinstated.

If a SUSPENDED producer submits an application for assignment, the assigned company must request that the named insured designate an alternate, certified producer of record; in the event that no alternate producer is designated, the SUSPENDED producer may NOT earn premium compensation upon renewal of the policy. If the producer's suspension has been lifted, the insured may contact the carrier to advise the producer is now certified to remain producer of record.

A producer may be placed in a REVOKED status either by revocation of the producer's certification status by TAIPA Governing Committee action or by revocation of the producer's license through action taken by the Texas Department of Insurance. Revocations are for specific time periods, not on a policy-per-policy basis.

A REVOKED producer may NOT utilize TAIPA's electronic binding program, may NOT earn premium compensation on applications submitted while revoked, and may NOT service EXISTING nor RENEWAL policies while revoked. Producers who have been REVOKED by TAIPA Governing Committee action must attend a training course at TAIPA before the revocation will be lifted and the certification status reinstated.

If an assignment is flagged "REVOKED" the assigned company must request that the named insured designate an alternate, certified producer of record; in the event that no alternate producer is designated, the producer may NOT earn premium compensation upon renewal of the policy.
