Chair Becky Jackson called the meeting to order at 8:34am. Chair Jackson asked Stacy Dutton to call roll.

Chair Becky Jackson asked Stacy Dutton to read the Anti-trust statement. Ms. Dutton read the Anti-Trust Statement:

#### **TAIPA Anti-Trust Statement**

The creation and operation of the Texas Automobile Insurance Plan Association is set forth in Chapter 2151 of the Texas Insurance Code. The Association is a non-profit corporate body composed of all authorized insurers.

The organization was created to provide a means by which insurance may be assigned to an authorized insurer for a person required by the Texas Motor Vehicle Safety-Responsibility Act to show proof of financial responsibility for the future.

Members of the Association and of its Governing Committee, when involved in meetings or other activities of the Association, are bound to limit their discussions and actions to matters relating to the business of the Association and shall not discuss or pursue the business interest of individual insurers or others.

Chair Becky Jackson asked Stacy Dutton if there was a quorum present. Ms. Dutton stated that there was a quorum present.

Chair Becky Jackson asked Stacy Dutton to report on the Trade Association Representatives. Ms. Dutton stated that the 2024 Trade Association Representatives selected are:

- American Property Casualty Insurance Association (APCIA) -Appointed Travelers Insurance Company as their representative
- National Association of Mutual Insurance Companies (NAMIC) -Appointed Hochheim Prairie Insurance as their representative
- Association of Fire & Casualty Companies in Texas (AFACT) -Appointed Texas Farm Bureau as their representative

Chair Becky Jackson reminded everyone that no one applied for the Non-affiliated position in 2023. Therefore, the Governing Committee approved a Plan of Operation change to eliminate the Non-Affiliated position and replace it with a 5<sup>th</sup> At-Large position with a preference to fill it with a Texas domestic insurance company that writes only in the State of Texas and is not an affiliate or a subsidiary of an insurance company or holding company system writing automobile insurance outside of Texas.

Chair Jackson then reported the nominees for at-large representatives of insurers were:

- o Farmers Insurance
- o Safeco/Liberty Mutual
- o State Farm Mutual Automobile
- O United Services Automobile Association (USAA)
- o Allstate Insurance

Chair Becky Jackson asked Stacy Dutton if all the voting insurer members sent their votes in. Ms. Dutton confirmed the members had sent their votes in.

Chair Jackson then asked if there were any write-ins. Ms. Dutton indicated that there were no write-ins.

Chair Becky Jackson stated since there were only five candidates for five open positions, she requested a call for their election by acclamation. Chair Jackson then asked for a motion to accept the slate of candidates presented.

Ramon Montalvo made a motion to accept the slate of candidates presented. Matthew Snyder seconded this motion. The motion passed unanimously with no abstentions.

Chair Becky Jackson announced the five insurers elected for a term of one year commencing upon adjournment.

Chair Becky Jackson stated that the Chair and Association Manager's Reports were sent out with the agenda.

Chair Jackson requested a motion to adjourn. John Lusardi made a motion to adjourn. Brian Ferguson seconded the motion. The motion to adjourn passed unanimously with no abstentions.

Chair Jackson announced the meeting adjourned at 8:41am.
