**Regarding:** Updates Effective January 1, 2010

Limited Assignment Distribution (LAD) and Commercial Limited Assignment Distribution (CLAD) servicing carriers

- Effective January 1, 2010, Lincoln General Insurance Company will no longer be a LAD/CLAD servicing carrier.
  - Any carrier(s) in a 2009 contract with Lincoln General will not be able to renew services into the 2010 term.
  - Any assignments previously placed with Lincoln General Insurance Company will remain their responsibility until the end of the assignment period, as stated in the TAIPA Plan of Operation (Sections 41 and 42) which can be located at [www.taipa.org](http://www.taipa.org).
- At the September 2, 2009 TAIPA Governing Committee meeting, Praetorian Insurance Company was approved as a CLAD servicing carrier.
  - Previously, Praetorian was a Texas LAD servicing carrier.
  - Effective January 1, 2010, Praetorian will be a LAD and CLAD servicing carrier.
- At the September 2, 2009 TAIPA Governing Committee meeting, National Liability & Fire Insurance Company was approved as both a LAD and CLAD servicing carrier, effective January 1, 2010.


